Stud Fee and Payment

1. The total stud fee for Bank On the Best is \$1,750.
 - This includes \$650 for collection and shipping fees.

2. A \$500 non refundable deposit must be paid upon booking. Bookings made prior to 12/31/2024 will be subject to an early booking discount, if applicable.
_____ has been offered as the early booking discount.

3. The \$1,750 stud fee must be paid in full prior to shipment or service.
 - Payment can be made via credit card (with a 4% processing fee) or via Venmo/PayPal Friends and Family.

Rebreed Fee

In the case of a rebreed under the Live Foal Guarantee, a rebreed fee of \$650 will apply. This fee covers collection and shipping costs.

Live Foal Guarantee

1. This contract includes a Live Foal Guarantee. A live foal is defined as a foal that stands and nurses without assistance.
2. If the mare fails to produce a live foal, the mare owner will be entitled to a rebreed for the same mare or a substitute mare approved by the stallion owner.
3. The mare owner must notify the stallion owner within 48 hours of foal loss or stillbirth, and a licensed veterinarian must provide certification of the event for the Live Foal Guarantee to be honored.

Breeding and Shipping

1. The mare owner is responsible for all veterinary and boarding expenses related to the mare during the breeding process.
2. Collection and shipping costs are included in the initial stud fee of \$650. Additional charges may apply for international shipments or special requests.
3. The mare owner must provide at least 48 hours' notice for semen shipment requests.
4. The stallion owner will ship semen in good faith for timely arrival using a proper delivery method. However, shipping delays, disruptions, or destruction are not the responsibility of the stallion owner. If shipping issues arise due to third-party carriers, a repeat collection and shipping fee will be the mare owner's responsibility.
5. The mare owner must provide a copy of the mare's registration papers upon booking to ensure accuracy in the breeding report.

Health Requirements

The mare owner must provide the stallion owner with a current negative Coggins test and veterinary certification that the mare is free from any contagious diseases or infections prior to shipment or live cover.

Breeding Responsibility Disclaimer

The mare owner is responsible for conducting their own research and due diligence regarding genetic combinations and the suitability of this breeding. The stallion owner makes no guarantees regarding the future performance, conformation, or success of the offspring produced from this breeding.

Release of Liability and Hold Harmless Agreement

The mare owner agrees to release and hold harmless the stallion owner, Kathryn Sneed, and any associated agents, employees, or contractors from any and all liability, claims, or damages arising from the breeding process, transportation, care of the mare, or resulting foal. This includes but is not limited to injury, illness, or death of the mare or foal, as well as any economic losses or damages.

The mare owner acknowledges that the stallion owner does not guarantee the mare's conception or the live birth of a foal, except as specified under the Live Foal Guarantee, and that the stallion owner is not responsible for any unforeseen circumstances related to the breeding process.

Substitution of Stallion Semen with Frozen If Applicable

Should Bank On the Best become unavailable due to illness, injury, or death, the stallion owner reserves the right to provide frozen semen in place of fresh-cooled semen.

Governing Law

This contract shall be governed by the laws of the state of Tennessee.

Entire Agreement

This contract constitutes the entire agreement between the parties and may not be amended except in writing and signed by both parties.
